3. FIBA will inform the organisers of the exact arrival date/time/flight number so that you will be met at the airport and transferred to the hotel.
4. The FIBA Clinic for all FIBA Commissioners, Referee Supervisors and Referees will be held before the championship as follows:

Venue: Hotel for FIBA Referees

Date: 22<sup>nd</sup> July 2007, 9:00 – 17:00

The arrival of all participants in Bangkok must be on 21<sup>st</sup> July 2009 late evening at the latest.

Program: The clinic will focus on Three-Person Officiating and the Unification of the Officiating Criteria. The official FIBA Physical Fitness Test will also be held for all FIBA Referees who must have their weight very proportional to their height.

5. All Referees will be provided with a complete set of the Referee's Uniform and you will be asked to use it during the championship. However you are requested to bring your black shoes and referee's shirt(s) with you.
